

## GUIDELINES FOR NEW PATRONS OF JET

**UTILITIES:** Water, sewer, and trash services are furnished by the Town of Jet, and utility bills may be paid at the Jet State Branch; mailed to Jet Utilities Authority, P.O. Box 247, Jet Ok 73749 or placed in the mail drop box at the City Office. Electricity is furnished by Oklahoma Gas & Electric (OG&E), and natural gas service is furnished by Oklahoma Natural Gas (ONG).

**WATER:** a \$100.00 water meter deposit is required, and a Contract for Service must be signed. If a good payment history is established after one (1) year, the deposit will be credited to your water bill account. Bills are due and payable upon receipt. All bills unpaid on the 11<sup>th</sup>, will have a \$5.00 late fee assessed. A delinquent notice will be mailed to you on the 11<sup>th</sup> including the late fee. All delinquent accounts remaining unpaid on the 14<sup>th</sup> will receive a 24-hour notice of disconnection. Disconnection will occur as early on the 15<sup>th</sup> as possible, there will be a disconnect fee of fifty dollars (\$50.00). Before service will be restored to any disconnected service, the bill must be paid in full and disconnect fee plus a reconnecting fee of fifty dollars (\$50.00) will be charged for any reconnected service disconnected due to unpaid bills. Scheduled dates from time to time fall on weekends and holidays, therefore, the next day of business following will prevail.

Water Rates:	0 – 2000 Gallons	\$20.00
	2001 – 6000 Gallons	\$2.25 per 1000 gallons
	6001 – and above	\$2.75 per 1000 gallons

**SEWER:** Sewer charges are tied in with the water furnished by the City.  
Rates are determined upon water usage.

Sewer Charges:	0 – 2000 Gallons	\$11.00
	2001 – 6000 Gallons	.75 per 1000 gallons
	6001 – and above	1.00 per 1000 gallons

**TRASH:** Trash is also tied in with the water furnished by the City and will be picked up every Tuesday sometimes around 7:00 a.m. If not, please contact Davis Sanitation at 1-800-522-6437.

Trash Charges: \$11.00 per month for Residential.

**ANIMALS:** All pets and/or animals must either be fenced in or restrained; this is City Code Sec. 4-101. All dogs and cats must be registered and vaccinated against rabies. Also, pet registration must be purchased at the City Office with a Certificate of Vaccination.

**CITY OFFICE HOURS** Are Monday through Thursday from 9:00a.m. to 12:00 noon and 1:00p.m. to 3:00p.m. If you have any questions, please contact the City Office at 626-4401 during office hours or leave a message on the answering machine. The messages are checked daily, and someone will return your call as soon as possible.
